ABOUT NEWPORT LIVE CASNEWYDD FYW

Would you not want to help Newport live have a greater impact in the city of Newport?

Newport Live is a charity providing sporting, leisure and cultural activities in Newport to support the health and wellbeing of people in the city and beyond, inspiring everyone to become happier and healthier.

As a non profit distribution organisation and registered charity all the surplus income we create is invested back into the services and facilities we offer – so Newport Live customers help us to support our local community to improve their wellbeing.

Newport Live delivers a wide range of services at Newport International Sports Village (NISV), which is home to the Geraint Thomas National Velodrome of Wales, Regional Pool and Newport Tennis Centre and Newport Stadium. The Riverfront Theatre and Arts Centre, Station are in the centre of the city and the Active Living Centre, Bettws.

Newport Live provide coaching and participation programmes throughout the wellbeing, sport, physical activity, education, arts and sport sectors, from grassroots to high-performance. They strive to encourage participation, the achievement of personal goals, improved wellbeing, fun and inclusivity.

Newport Live have hosted many high-profile events including the Big Splash festival, World Class acts, international competitions and sporting events, including training camps for the Team GB and Paralympics GB cycling teams.

The charity continue to develop the Big Splash having created and developed the largest outdoor street arts festival in Wales. The Riverfront Theatre welcome over 25,000 to the city during the 2-day event. Plans are already well underway to further expand the festival for 2025.

Newport Live's Sports and Arts Development teams are highly regarded locally, regionally, and nationally by partners which includes; Sport Wales, Arts Council of Wales, Disability Sport Wales, Street Games, the Office of the Police and Crime Commissioner for Gwent, Newport City Council, Welsh Government, Tennis Wales, Swim Wales, Beicio Cymru, LTA, Aneurin Bevan

University Health Board, Public Health Wales, Youth and Social Services together with a wide range of other partners.

The Newport Live team have won a number of national awards and has been recognised for their innovation and best practice. The team delivers and

facilitates high quality sport, education and arts opportunities for children, families, schools, communities, clubs, and local groups across Newport and wider areas of South Wales.

Newport Live recognise how sport, physical activity, theatre, arts and culture can have such a positive impact on mental and physical wellbeing. It enhances lives and improves social value across our regions and importantly recognises and responds to urgent needs. The team strive to make a difference in the community to improve wellbeing and encourage lifelong participation and engagement in sport and the arts.

VENUES

NEWPORT INTERNATIONAL SPORTS VILLAGE

GERAINT THOMAS NATIONAL VELODROME OF WALES

The Geraint Thomas Velodrome is one of only five international indoor velodromes in the UK and can host up to 1,700 spectators. It is also home to two gyms as well as new and improved fitness studio, indoor group cycling studio, outdoor cycle speedway track, 3G pitch, BMX pump track, 12 badminton courts inner arena and has many conferencing areas.



The Regional Swimming Pool and Newport Tennis Centre has a 25m eight-lane competition swimming pool able to host 625 spectators and has a 12m x 8m teaching pool. Newport Tennis Centre is one of just 6 outdoor centres in Wales and has 4 indoor and 3 outdoor floodlit tennis courts. On site there is also a large newly developed digitally powered gym, large café, an outdoor multi use games area, a children's outdoor playground and various meeting rooms.

NEWPORT STADIUM

Newport Stadium is highly flexible athetics and multisport outdoor venue with meeting rooms to hire. Home to Newport Harriers Athletic Club, Newport RFC, Newport City FC and is Newport County AFC's training facility. The stadium can accommodate 2,450 spectators and can stage international stand track and field athletic events.













▼ THE RIVERFRONT THEATRE AND ARTS CENTRE

The Riverfront is at the heart of the arts and entertainment scene in Newport, which brings as many people as possible into contact with the arts and creative industries. It is the City's only professional theatre and arts centre. Two theatre spaces are able to accommodate audiences of 500 and 128 people and along with the only cinema in the centre of the city, an art gallery, a dance studio, multiple workshop rooms, conferencing facilities a café and bars. The Riverfront has recently received funding from the Arts Council of Wales to support sector leading investment into de-carbonisation and energy efficiency, improving the building and artistic activities.

STATION

Station is a gym, wellbeing and activity centre, located in the city centre, opposite Newport's train station. The facility has over 120 stations to host of both new and familiar market-leading equipment. We're passionate about delivering health and fitness to the community and Station is a phenomenal interim wellbeing and activity centre which replaced Newport Centre.

Momentum Active Travel secure cycle storage is located within the facility.

ACTIVE LIVING CENTRE

The Active Living Centre is based in the heart of the Bettws Community, by day and term-time it is Newport High School. Newport Live operates the leisure facilities during evenings, weekends and holiday periods. The centre is home to a 25m four-lane swimming pool, gym, a dance studio, 4 badminton courts, sportshall, floodlit astroturf pitch, an outdoor multi-use games area, 4 outdoor tennis courts and football pitches.

DUTIES & RESPONSIBILITIES OF OUR NON EXECUTIVE DIRECTORS/ TRUSTEES

THE RESPONSIBILITIES:

- Charity trustees are the people who serve on the governing body of a charity. They may be known as trustees, non executive directors, board members, governors or committee members. The principles and main duties are the same in all cases.
- Trustees have and must accept ultimate responsibility for directing the affairs of a charity, ensuring that it is solvent, well-run, and delivering the charitable outcomes for the benefit of the public for which it has been set up.

ENSURE COMPLIANCE - TRUSTEES MUST:

- Ensure that the charity complies with charity law and with the requirements of the Charity Commission as regulator; in particular ensure that the charity prepares reports on what it has achieved and Annual Returns and Accounts as required by law.
- Ensure that the charity does not breach any of the requirements or rules set out in its governing document and that it remains true to the charitable purpose and objects set out there.
- Comply with the requirements of other legislation and other regulators (if any) which govern the activities of the charity.
- Act with integrity, and avoid any personal conflicts of interest or misuse of charity funds or assets.

DUTY OF PRUDENCE - TRUSTEES MUST:

- Use charitable funds & assets reasonably.
- Ensure that the charity is and will remain solvent.
- Use charitable funds and assets reasonably, and only in furtherance of the charity's objects.
- Avoid undertaking activities that might place the charity's endowment, funds, assets or reputation at undue risk.
- Take special care when investing the funds of the charity, or borrowing funds for the charity to use.
